- **Youth Suicide Awareness:** With care and sensitivity, this course discusses mental health concerns such as anxiety and depression, and helps students better identify youth suicide risk – in themselves and in others – so that they can intervene and/or ask for the support that is needed.
- **Alcohol & Drug Prevention:** This course identifies the social pressures teenagers face today in regard to alcohol, marijuana, vaping, prescription drugs, and other substances; explains the effects that they can have on their health and future, specifically covering the dangers of binge drinking, driving while intoxicated, and sexual assault; and, offers strategies teens can use to resist these pressures.

- **Sexual Harassment:** This course defines sexual harassment for students – what it looks like and its various forms – as well as discusses and defines consent, the difference between sexual harassment and bullying, and what students can do to help put a stop to sexual harassment.
- **Digital Citizenship:** This course helps students learn how to navigate and interact safely in today’s modern digital world while exploring all the conveniences, opportunities, challenges, and responsibilities it affords.

Courses for students in grades 9-12 will be available in June to be used for the 2019-20 school year, but can be preordered now.
